

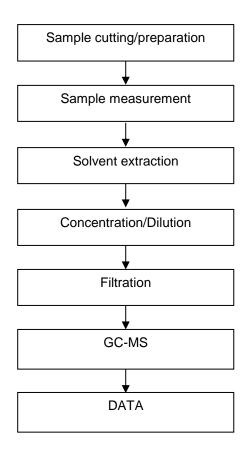

Phthalates Testing Flow Chart








